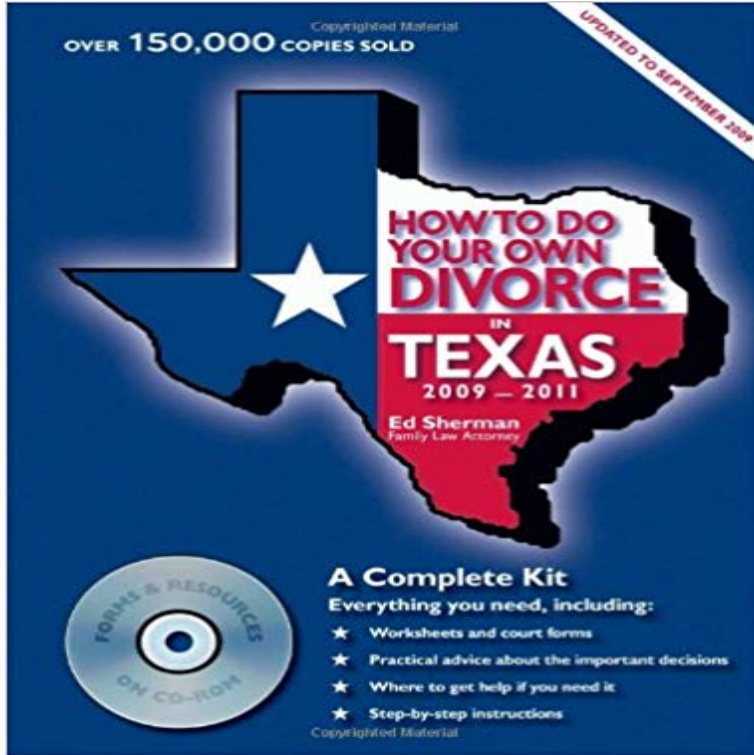


# How to Do Your Own Divorce in Texas, 2009-2011: A Complete Kit
